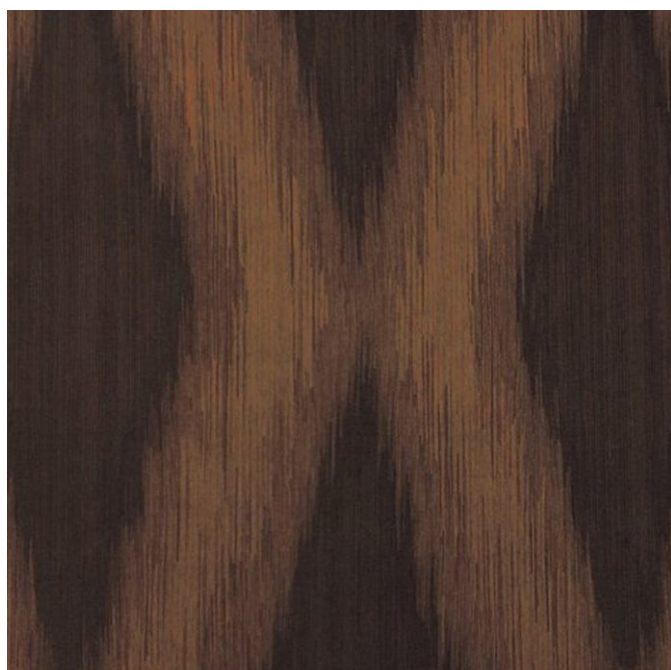

Inherently fire retardant, Kite meets BS5867 Part 2 Type B, making it suitable for commercial environments including hotels, restaurants and leisure interiors.
